Subject: Clarification regarding signing-up by the Government Organisations/ government promoted Organisations on the NGO-PS Portal of NITI Aayog for applying for grants from Central Government Departments/ Ministries.

As per the recent decisions by the Government of India, it is mandatory for all the NGOs/VOs to sign up on the NGO-PS Portal (NGO-DARPAN) to obtain a system generated Unique ID before applying for grant under any scheme of the Central Government Department/ Ministry.

2. NITI Aayog has been receiving queries in this behalf as to whether government organisations or government promoted organisations (i.e. Central or State), are also required to comply with the requirement of signing up on the Portal to obtain the system generated Unique ID.


3. It is clarified that the Portal is only meant for the Non-government Organisations (NGOs) with the objective of bringing in transparency in their operations. The Government promoted Organisations are not required to register on this Portal. It shall be entirely the decision of the concerned Department/ Ministry to consider sanction of grants under any of its schemes to any such organisation if it finds such organisation eligible and compliant with other conditions under the
