**Subject : Registration of NGOs on NGO-PS Portal of NITI Aayog- regarding**

This is regarding the project proposal being sanctioned under various schemes of Office of the DC(handicrafts). In this context it is to inform that in compliance to RoD of the meeting taken by the Hon'ble Prime Minister to review the progress in Unique Identifier, Aadhar and DBT dated 09.05.2016 and as per the NITI Aayog guidelines NGOs receiving grant-in-aid from Government of India are required to be registered on NGO-PS Portal of NITI Aayog and submit details of Aadhar and Pan Numbers of all their trustees and office bearers enabling this office to process and release grants.

It is accordingly requested to guide the NGOs for getting their names registered on the NGO-PS portal of NITI Aayog and send the unique ID number obtained after registration along with the Aadhaar number and Pan Numbers of all the trustees and Office-bearers of the respective organization to the concerned divisions of Headquarters Office both by e-mail and post enabling further release of grants. **The above condition shall also be applicable for NGOs empanelled with TISS, Mumbai. The necessary guidelines of NITI Aayog procedure regarding NGOs partnership are available at <http://ngo.india.gov.in/auth/default.php> and the copy of the same is also enclosed for ready reference.**

These instructions will be followed in respect of all the sanctioned activities of Grant-in-aid schemes of Office of the Development Commissioner (Handicrafts).

# NITI Aayog Procedm. reg. NGO Partnership

## NGO Partnership Registration

To get Projects for funds from Government of India Registration with NITI Ayog is mandatory

Process for Registration and to get Unique Identification Number for the NGO partnership system with Planning Commission of India (NITI Ayog):

NITI Ayog (Planning Commission of India) invites all Voluntary Organisations / Non – Governmental Organisations / Non – Profit Organisations to Signup and get Registration on the NGO partnership system (NGO-PS) at the following website:

Following are required for registration with NITI Ayog and to get Unique Identification Number:

Pan Card is necessary to get Registration in NGO Partnership.

Have to provide details of PAN and Aadhaar numbers of all the position holders and trustees of the NGO.

Trustees, Society members and office holders of the NGOs must declare their moveable and immovable properties, cash, personal assets and jewellery, by July 31.

NGO Partnership is a free facility provided by Government of India at the planning Commission of India (NITI Ayog) to bring about partnership between Government and the voluntary sector Non (Governmental Organizations) and foster better transparency, efficiency and accountability.

After getting Registration with NGO Partnership NGOs will be enable for following options and facilities:

- To get details of existing VOs/NGOs across India.
- To get details of grant schemes of key Ministries/Departments of Government of India.
- NGO can apply online for NGO grants of Government of India. As it is compulsory to have registration with NGO Partnership to get approval for grants from any Government Ministry or Government Department.
- NGO management can track status of application of NGO for grants from Ministries/Departments of Government of India.

It must be clear that if any NGO is registered at NGO Partnership that does not imply that NGO is endorsed or recommended by NITI Aayog or by the concerned Ministries or Departments or Government Bodies. This registration is only for getting funding from Government Ministries and Departments, as it is necessary for that process. And all the registered NGOs at NGO Partnership will surely not get funds, only the selected NGOs can get grants; and it is upto the authorities of concerned Ministries or Departments or Government Bodies who section the grant.

In order to strengthen services of the portal, Government has decided to make PAN Number of VOs/NGOs mandatory. All VOs/NGOs are hereby requested to add/update their organisation PAN Number

The NGO-Partnership System (NGO-PS) Portal was earlier maintained by erstwhile Planning Commission, which has been replaced by the NITI Aayog w.e.f. 1st January, 2015. The NGO-PS Portal, therefore, is being maintained at present under the aegis of NITI Aayog. NITI Aayog invites all Voluntary Organizations (VOs)/ Non-Governmental Organizations (NGOs) to Sign Up on this system. The portal facilitates VOs/NGOs to figure in the database system of the Voluntary Sector maintained by NITI Aayog and also helps them to apply online for Governments Grants under various schemes of the below mentioned Ministries/Departments/Governments Bodies.

Voluntary and Non-Governmental Organisations(NGOs) play a major role in the development of the nation by supplementing the efforts of the Government. NGO-Darpan is a portal to enable NGOs to enrol centrally and thus facilitate creation of a repository. It would also facilitate the Ministries/Departments to view the details of NGOs enrolled in different sectors/states
