NOTICE INVITING APPLICATIONS FROM HANDICRAFT ARTISANS FOR ALLOTMENT OF STALLS
IN DILLI HAAT (MARKETING OPPORTUNITY)**

Dilli Haat at (INA) provides an excellent marketing opportunity throughout year for the artisans of various parts of India. The stalls will be allotted here for the artisans on fortnight basis for sale of their products directly to the customers.

Applications on prescribed format are invited from handicrafts artisans (which includes carpet weavers) for allotment of stall in Dilli Haat on fortnight basis for the period starting from 01.05.2016 to 15.10.2016.

Eligibility Conditions:-

1. Artisans should have ID Card issued by the field offices of office of DC (Handicrafts) registered with the Marketing & Service Extension Centers or other field units of the office of the Development Commissioner (Handicrafts), Ministry of Textiles, Government of India.
2. The artisans who have participated at Dilli Haat during the last six months is not eligible.
3. Selected artisans will have to submit Demand Draft of Rs.5,000/- payable to Accounts Officer (Hqrs.) Office of the DC (Handicrafts), New Delhi towards security deposit in case the selected artisans could not participate or transfer the stalls to other artisans the security amount shall be forfeited.

The interested artisans may send their applications to the concerned field office of the Development Commissioner (Handicrafts) under which he/she is registered alongwith a photocopy of their Identity Card-cum-Passbook and copy of certificate in case of National Awardee or Shilp Guru artisan including, three passport size photographs. The applicant also required to give the name and address of the person who would assist him/her during participation at Dilli Haat and attach his/her two passport size photographs duly certified by a Gazetted Officer. The associate so nominated must preferably be his/her spouse, son/daughter or in also entirety resident of his/her native place. The applicant must indicate the fortnight for which he/she would like to participate. One applicant may apply for one or more or all the slots out of the slots.

The last date for receipt of applications by the concerned field office of the Development Commissioner (Handicrafts) is 19.04.2016. For slots 1 to 6 for the period from May to October, 2016. The selection of craftpersons from among those fulfilling the eligibility criteria will be made by respective field offices, in which the artisans have applied, through draw of lots on 22.04.2016 at 2.00 PM in presence of the applicants who wish to be present. For any clarification, the artisans may contact the concerned field office O/o the Development Commissioner (Handicrafts) in which they are registered.
