


This is in continuation to this office letter of even number dated 24.01.2022 regarding circulation of Internal Scheme Guidelines for organizing domestic marketing events.

In this connection, the following clarification has been made for payment of TA/DA and Freight charges to the artisans for all marketing events:

1. All the participating artisans (Pahchan card holder) as per quota sanctioned are eligible for payment of TA minimum to Rs. 1000/-, DA (except the artisans from same district/city) and Freight Charges irrespective of their participation through nomination/selection or dropout.
2. All the participants from other district from which event is organised, are eligible for TA minimum to Rs. 1000/-, DA and Freight Charges as admissible.
3. As of now, there is no limit of participation or exemption for payment of TA/DA and Freight Charges to the artisans. The artisans who left the event before completion are not eligible.
